 - (a) Financial statements must be prepared with reasonable estimates of revenues and expenses, protection of Toquaht assets and evidence of maintaining internal controls

 - (c) RHN reviewed the financial statements for 2022-2023 and found very few areas where minor adjustments were recommended and consider them accurate

- 4) Lands, Public Works and Resources David Johnsen, director of lands, public works and resources
 - a) The Marine Stewardship Program has conducted land and ocean patrols, data collection, surveys such as oyster, clam, deer, elk
 - **b)** Aquatic Habitat Restoration
 - i) Enhancing our knowledge of the salmon populations in the territory and river health
 - ii) Developing restoration strategy for Maggie, Toquaht, & Chenatha Watersheds
 - iii) Highlight actionable opportunities for restoration and salmon enhancement
 - iv) Solutions to fish passage issues at Maggie fish ladder
 - **v)** Collaborating with Thornton Creek Hatchery
 - c) Food Fish
 - i) We are working on ways to catch more fish of different types and how this can be processed for delivery, such as getting different types of salmon smoked, and canned, smoked black cod
