### **PART 1 - INTRODUCTORY PROVISIONS**

### **Short title**

1.1 This regulation may be cited as the Ticketable Offences Amendment Regulation No. 1.

### **Application**

- **1.2** This regulation amends or prescribes
  - (a) certain ticketable offences,
  - (b) for the purposes of section 5.2 of the Act,
    - (i) the particulars of those offences, and
    - (ii) the penalty, discounted penalty and surcharge penalty for those offences.

### **Definitions**

**1.3** In this regulation,

"Act" means the Enforcement Act.

### **PART 2 - TICKETABLE OFFENCES**

### **Ticketable offences**

- 2.1 The Compliance Notice and Ticket Regulation is amended by
  - (a) repealing Schedule 2-1 and substituting Schedule 2-1 of this Regulation,
  - (b) adding the following two rows to Schedule 2-2 immediately following the seventh row [*Intimidate individual to vote or refrain from voting*]:

10.2	Interfere or attempt to interfere with casting of electronic vote	\$250	\$200	\$375

- (c) repealing Schedule 2-8 and substituting Schedule 2-8 of this Regulation, and
- (d) adding Schedules 2-10 and 2-11 of this Regulation as Schedules 2-10 and 2-11 of the Compliance Notice and Ticket Regulation.

### **Consequential amendments**

2.2 Section 4.1 and Schedule 3 of the Business Licensing Regulation are repealed.
