PART 1 - INTRODUCTORY PROVISIONS

Short title

- 1.1** This regulation may be cited as the Miscellaneous Amendments Regulation No. 1 (Toquaht Nation).

Authority and application

- 1.2** This regulation applies to miscellaneous Toquaht Nation regulations.

PART 2 - BUILDING FORMS REGULATION

Building Forms Regulation amendments

- 2.1** The Building Forms Regulation (Toquaht Nation) is amended as follows:
- (a) section 2.1(a) is amended by striking out the words “are established” and substituting “are prescribed”; and
 - (b) Schedule 1 is amended as follows:
 - (i) the heading to form BR-4 is amended by inserting the words “OF AUTHORIZATION” after the word “REVOCATION”.

PART 3 - BUSINESS LICENSING REGULATION

Business Licensing Regulation amendments

3.1 The Business Licensing Regulation (Toquaht Nation) is amended as follows:

- (a) section 1.3 is amended by repealing the definition of “ticketable offence”; and
- (b) by repealing Part 4.

PART 4 - ENFORCEMENT STANDARDS REGULATION

Enforcement Standards Regulation amendments

4.1 The Enforcement Standards Regulation (Toquaht Nation) is amended as follows:

- (a) section 2.2(e) is amended by striking out the words “, a special Toquaht prosecutor appointed under section 2.5 of the Enforcement Act”.

PART 5 - EXPENDITURES REGULATION**Expenditures Regulation amendments**

5.1 The Expenditures Regulation (Toquaht Nation) is amended as follows:

- (a) section 3.2 is amended by striking out the reference “6.3(b)” and substituting “6.3(c)”.

PART 6 - FISHERIES REGULATION**Fisheries Regulation amendments**

6.1 The Fisheries Regulation (Toquaht Nation) is amended as follows:

- (a) section 4.7(d) is amended by striking out the words “fishing licence at the times” and substituting “fishing licence is authorized to harvest, at the times”.

PART 7 - HOUSING REGULATION

Housing Regulation amendments

7.1 The Housing Regulation (Toquaht Nation) is amended as follows:

- (a) by repealing section 4.9(c);
- (b) by repealing section 5.1;
- (c) the heading to Schedule 3 is amended by striking out the word “ASSESSMENT” and substituting “ASSESSMENT”; and
- (d) by repealing Schedule 6.

PART 8 - TOQUAHT TITLED LANDS TRANSFER REGULATION

Toquaht Titled Lands Transfer Regulation amendments

- 8.1** The Toquaht Titled Lands Transfer Regulation (Toquaht Nation) is amended as follows:
- (a) section 1.3 is amended as follows:
 - (i) the definition of “Director” is amended by striking out the words “Lands, Public Works and Resources” and substituting “Lands and Resources”; and
 - (b) section 4.1(c) is amended by striking out the words “Lands, Public Works and Resources” and substituting “Lands and Resources”.
